

KISS-FM Anita Baker Here and There!

Official Contest Rules

These rules apply to **KISS-FM Anita Baker Here and There!** Contest (“Contest”) conducted by **Beasley Media Group, LLC** d/b/a WDMK (“Station”). **In addition, the General Contest Rules posted at www.KISSFMDETROIT.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on June 5, 2023, and end on June 30, 2023.
- b. To enter on-air, listen to the Station each weekday beginning on June 5, 2023 and ending on June 30, 2023 between the hours of 6:00am Eastern Time (“ET”) and 8:00pm ET for two (2) of Anita Baker songs to play back to back, which will serve as the cue to call. Note: the Contest will end at 10:00am ET on June 30, 2023 and the cue to call will air prior to 10:00am ET on June 30, 2023. Upon hearing the beginning of the second song, the songs playing back to back, the tenth (10th) caller to the Station contest line at 313-568-1059 will win a Qualifying Prize and be qualified for a chance to win the Grand Prize, upon confirmation of eligibility. Station is not responsible for any failure of a caller to reach the Station contest line including but not limited to busy phone lines, misdirected calls, equipment breakdowns, or disconnections. Calls will only be accepted at the designated phone number. At the time of entrant’s call, entrant will be required to provide all information requested including entrant’s full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller who successfully makes it through on the call-in line and completes the call will be a Qualifier. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a Qualifier only once.
- c. There will be up to a total of twenty (20) Qualifying Prize winners and one (1) Grand Prize winner selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in the Detroit Metro Area, consisting of the following Michigan counties: Lenawee, Monroe, Wayne, Washtenaw, Jackson, Hillsdale, Ingham, Livingston, Oakland, Macomb, St. Clair, Lapeer, Genesee, and Shiawassee; and the following Ohio Counties: Lucas, Fulton, and Williams, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

- b. Limit one (1) winner per household.

3. PRIZES

- a. Up to twenty (20) Qualifying Prizes will be awarded. Each Qualifying Prize is being provided by Capitol Records and consists of two (2) lawn tickets to see Anita Baker at Pine Knob Music Theatre located at 33 Bob Seger Dr, Village of Clarkston, MI 48348 on July 2, 2023. Approximate Retail Value of each Qualifying Prize is \$134.30.

The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). The prize(s) is awarded as is. Tickets valid only on the date(s) printed on the tickets. Tickets are not refundable or transferable, and may not be substituted or exchanged for cash or credit at any time, nor will tickets be replaced if lost or stolen. Tickets may not be sold to a third party. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond control of the Station and/or prize provider, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded element(s) of the prize(s). The Station and/or venue, in their sole discretion, reserve the right to deny entry to or to remove the winner(s) and/or guest(s) if either engages in disruptive behavior, does not follow Station and/or venue policy regarding COVID-19 guidelines, or in a manner with intent to annoy, abuse, threaten or harass any other person at the prize-related event. Winner understands that there are inherent risks involved in attending the prize-related event.

- b. Up to one (1) Grand Prize will be awarded. The Grand Prize is being provided by Capitol Records and consists of: Two (2) tickets to see Anita Baker, Round-trip coach class airline tickets for one (1) winner and one (1) guest and a two (2) night hotel stay (standard room, double occupancy) for one (1) winner and one (1) guest at a destination to be determined by the Grand Prize winner from list of destinations below. ARV of the Grand Prize will be determined by which destination location is selected by winner and will range between \$1,500- \$4,000.

Grand Prize winner will choose which destination they want to see Anita Baker at one of the five (5) locations below (subject to availability).

Dallas, TX: American Airlines Center, 2500 Victory Avenue, Dallas, TX 75219, Anita Baker show date is December 17, 2023, trip will be December 15 through 17, 2023, Sat-Mon (check out Mon and return home Monday)

Los Angeles, CA: Crypto.com Arena, 1111 S. Figueroa St, Los Angeles, CA 90015, Anita Baker show date is December 22, 2023, trip will be December 22 through 24, 2023, Fri-Sun (check out Sun and return home Sunday)

Oakland, CA: Oakland Arena, 7000 Coliseum Way, Oakland, CA 94621, Anita Baker show date is December 23, 2023, trip will be December 22 through 24, 2023, Fri-Sun (check out Sun and return home Sunday)

Prizes are non-transferable, cannot be sold or gifted, may not be redeemed for cash, and will not be replaced if lost or stolen. Extensions to expiration dates will not be granted. Prize packages do not include travel to the departure airport or to the hotel (except as specifically included), meals (except as specifically included), incidentals, tips, telephone calls, airline baggage fees, or any other personal expenses incurred during the winner's stay. Airline and schedule are at the sole discretion of Capitol Records. Non-stop service may not be offered. The prize winner must be one of the passengers booked in the travel party. The winner and guest(s) must have all necessary photo identification and/or travel documents required for travel.

Actual value may vary and any difference between stated value and actual value will not be awarded. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the winner. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental

expenses incurred during the winner's stay. Winner and guest must abide by all airline, hotel, and venue policies. The winner and guest must sign all required releases prior to booking of any travel. If winner is unwilling or unable to travel on the dates specified, the prize will be forfeited and may be awarded to another winner at Station's sole discretion. All travel is subject to availability and restrictions. It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

- a. Up to twenty (20) Qualifying Prize winners will be selected as described in Section 1 of these Official Rules.
- b. Up to one (1) Grand Prize winner will be selected at approximately 10:00am ET on Friday June 30, 2023, in a Station-conducted random drawing from all Qualifiers. Potential Grand Prize winner will be notified by phone and/or email promptly following the random drawing.
- c. Odds of being deemed a Qualifier on-air depend on the number and order of calls received. Odds of a Qualifier winning the Grand Prize are up to 1 in 20.
- d. Entrants must listen to the Station but need not be present to be deemed a Qualifier on-air. Qualifiers need not listen to the Station or be present to win the Grand Prize.
- e. Grand Prize winner must confirm acceptance of prize within seven (7) days of

winning, or risk disqualification and selection of an alternate Grand Prize winner (time permitting) in a random drawing of all remaining Qualifiers.

f. Decisions of Station management with respect to the Contest are final.
